An Act to amend the Criminal Procedure Code.

ENACTED by the Parliament of Malaysia as follows:

Short title and commencement

- **1.** (1) This Act may be cited as the Criminal Procedure Code (Amendment) (No. 2) Act 2024.
- (2) This Act comes into operation on a date to be appointed by the Minister by notification in the *Gazette*.

Amendment of First Schedule

2. The Criminal Procedure Code [Act 593] is amended in the First Schedule by inserting after the item relating to section 507A of the Penal Code [Act 574] and the particulars relating to it the following items and particulars:

- 3. Clause 2 seeks to amend the First Schedule to Act 593 consequential to the introduction of the new sections 507B, 507C, 507D, 507E and 507F into the Penal Code [Act 574].
