## Cybersecurity Today: Where We Stand and What Lies Ahead

Cybersecurity risk is an emerging concern, be it for an individual or a corporation (large or small). While it is an emerging risk, it has existed since the late 1980s. It is only in the last five to six years that cybersecurity exposure has evolved rapidly since the rise of ransomware attacks in 2017 (ie WannaCry).

During the pandemic, cyberattacks increased significantly (including ransomware), as most companies have switched to working from home or remotely. Cyber adversaries exploited the security gaps in the remote access infrastructure (including in Malaysia). Hence, it is not a question of “if” it will happen, but rather “when” it will happen. Therefore, is Malaysia ready to battle in today’s cybersecurity threat landscape?
